# PILOT Program Information Sheet

## **PILOT Program Introduction**

- The title company will inform you as to how much to pay for your land taxes from the date of your closing until the 1<sup>st</sup> day of the following month
- As of the first of the month following the closing of your home, you entered into the PILOT program
   (Payment in Lieu of Taxes) and will no longer be paying property taxes; therefore, you will not be eligible for
   any totally disabled veterans, veteran, senior freeze, Homestead Rebate, or ANCHOR. However, legislation
   has been changed to include residents in a PILOT program to be eligible for the new StayNJ state program
   beginning in 2026!
- Quarterly charges incurred in a PILOT program are called a service charge, not a tax
- PILOT is based upon assessed improvements, land values and the current tax rate
- The Plumsted Township PILOT program is for a total of 30 years

## **Bill Calculation**

- PILOT bills are based upon 55% of the assessed improvement and land values multiplied by the service charge (same as the tax rate) for the first 5 years
- PILOT bills are based upon 100% of the assessed improvement and land values multiplied by the service charge (same as the tax rate) for years 6 - 30
- PILOT bills are for four quarters:
  - The actual 3rd and 4th quarters of the current year and the estimated 1st and 2nd quarters of the following year
  - If a PILOT bill does not show four quarters and/or shows a manual adjustment, the bill has been manually adjusted due to the date the home was purchased

### **Delinquencies**

- Interest of 8% per annum will be charged on amounts up to \$1,500.00
- Interest of 18% per annum will be charged on accounts over \$1,500.00
- A penalty of 6% will be charged on any delinquency in excess of \$10,000.00 at the end of the calendar year
- All unpaid balances will be eligible for the annual accelerated tax sale

#### Questions

- PILOT amounts due are <u>not</u> posted on the township website
- Please disregard any property information listed on the website as you do not pay taxes.
  Land tax is exempted at the end of the calendar year.

## **Payment**

- Payments are due February 1st, May 1st, August 1st and November 1st
- A 10-day grace period is permitted in which payments may be made without interest being charged
- Post-marks are not accepted for the date payment is received
- If a mortgage company is escrowing payments, the homeowner(s) must notify the Finance Department
- At this time, PILOT payments <u>cannot</u> be made by credit or debit cards
