New Business:

Mr. Sorchik recused himself from the meeting as the board discussed recommendations for the Fairgrounds Ordinance after the Land Use Board members reviewed the proposed Ordinance. The Fairgrounds Ordinance is an overlay zone adding additional permitted uses in the base RA-5 zone, for Agricultural Special Events. The purpose of this Ordinance is to provide that there could be additional permitted uses as outlined in the proposed Ordinance. Site plan approval by the Land Use Board would still be required. After discussion the Board recommended the Ordinance as submitted but to remove, #6 Treehouse for residential use. The recommendation and review is to formalize the Ordinance before it is presented at a public meeting and adopted by the Township Committee.

A memorandum will be sent to the Township Committee stating that a motion was made and seconded to recommend to the Township Committee to remove #6; Treehouse for residential use and to require site plan approval prior to any activity or use. A roll call vote of attending members were in favor for the recommendation, with Mr. Cuozzo and Chairman Hallock abstaining.
