All officers working in accordance with the Ocean County DWI Shared Services Agreement (Grant Reimbursement Programs) will be paid \$63 per hour (Township reimbursed \$70 to include employer payroll taxes), as per Shared Services Agreement Amendment with Ocean County. All officers working in accordance with the Drug Recognition Expert Callout Program and FAST Program shall be paid \$50 per hour (Township reimbursed \$55 to include employer payroll taxes). All officers working in accordance with the DDEF Grant shall be paid at their overtime rate. All officers working in accordance with State and Federal Grants, with the exception of DDEF, will be paid at the rate of \$55 per hour.
