ORDINANCE NO. 2023-01

AN ORDINANCE OF THE TOWNSHIP OF PLUMSTED, COUNTY OF OCEAN, STATE OF NEW JERSEY. AN ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK FOR CALENDAR YEAR 2023 (N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and

WHEREAS, N.J.S.A. 40A: 4-45.15 provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and

WHEREAS, the Township Committee of the Township of Plumsted in the County of Ocean finds it advisable and necessary to increase its CY 2023 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and

WHEREAS, the Township Committee hereby determines that a 3.5% increase in the budget for said year, amounting to \$126,282.33 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and

WHEREAS, the Township Committee hereby determines that any amount authorized herein above that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Township Committee of the Township of Plumsted, in the County of Ocean, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2023 budget year, the final appropriations of the Township of Plumsted shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$126,282.33 and that the CY 2023 municipal budget for the Township of Plumsted be approved and adopted in accordance with this ordinance; and

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

All positions shall be up to 35 hours per week, except where indicated differently in this ordinance.

The Deputy Municipal Clerk shall be compensated at the rate of \$150.00 per night meeting. The Zoning Officer, Deputy Zoning Officer and Code Enforcement Officer shall be compensated at the rate of \$75.00 per session for their required attendance at Court and Land Use Board meetings, with the approval of the Business Administrator. The Clerk assigned as Land Use Secretary shall be compensated at the rate of \$150.00 per meeting for Land Use Board meetings.

The Municipal Clerk, Deputy Municipal Clerk, Assistant Treasurer, Chief Financial Officer and Deputy Tax Collector shall be authorized to receive additional pay at the hourly rate of their annual salary in lieu of flex time for hours worked in excess of the normal thirty-five hour work week, but not to exceed forty hours in any week, with the approval of the Business Administrator.

The annual salary of the Municipal Court Administrator excludes all call-out compensation. In the event an hourly/part time Municipal Court Administrator and/or Deputy Court Clerk is needed, they will receive \$40.00 per call out and a court rate of \$100.00 per session. The Municipal Court Clerk (specifically noted in the salary resolution) shall be paid \$100 per session for DWI court sessions through the AERF Grant funds.

The salary scale for police officers is in accordance with the police collective bargaining agreement in effect at the time. All officers working in accordance with the Drug Recognition Expert Callout Program or FAST (Grant Reimbursement Programs) will be paid \$50 per hour (Township reimbursed \$55 to include employer payroll taxes). All officers working in accordance with the Ocean County DWI Program shall be paid \$63 per hour (Township reimbursed \$70 to include employer payroll taxes), as per Shared Services Agreement Amendment with Ocean County. All other grants will be paid at \$55 per hour, except for the DDEF Grant will be paid at the officer's overtime rate.

Employees will receive mileage reimbursement at the rate established by the Federal Internal Revenue Service for business use of personal vehicles. The rate shall automatically adjust in accordance with the amount specified by the Federal Internal Revenue Service. Travel must be on official Township business in accordance with Plumsted Township Ordinance 46-22.

Current EMT certification for patrolmen is \$500.00 per year in salary upon presentation of satisfactory proof of certification. A yearly stipend will be paid in the amount of \$500.00 to full-time permanent officers that possess and maintain a current EMT certification. The yearly stipend will be paid as a lump sum of \$500.00 through the regular payroll process the last pay period of the year.

Longevity payments are authorized in accordance with Longevity Ordinance 2001-19 and subsequent amending Ordinance 2006-31 for full-time employees. Longevity payments are not considered part of the base salary. Longevity payments are added to the base salary and paid biweekly. Ordinance 2018-12 froze longevity for all employees.

The General Maintenance Working Supervisor and/or laborer shall be compensated at the rate of \$75.00 per meeting for attendance at Recreation Committee meetings up to a maximum of six (6).

SECTION II. The officers, employees and governing body of the Township of Plumsted shall be paid in the following manner:

ANNUALLY: Mayor, Township Committee Members, Public Safety Director (If \$1.00 annually)

MONTHLY: Judge (Mayor, Township Committee Members, Public Safety Director—if paid more than

\$1.00)

BIWEEKLY: All other positions

The pay week for biweekly payroll shall commence on Monday of the first week and run through Sunday of the second week. Pay day will be on Wednesday after the payweek ends. All hourly employees will be paid one week behind example, if the pay week ends on the Sunday before the payday, they will be paid through the Sunday of the previous week).

In the event that the Governing Body determines that it is deemed necessary to close the administrative offices due to inclement weather or a malfunction of facilities in the administration building, hourly part-time employees may be paid at their regular hourly rate of pay for their normal scheduled working hours.

SECTION III. Any salary, wage or compensation not herein mentioned shall remain the same as heretofore.

SECTION IV. The salaries, wages and other compensation listed above shall be payable from January 1, 2023, or the date of appointment, whichever is later, pursuant to a resolution adopted by the Township Committee specifying the amount of compensation within the authorized ranges and effective date.

SECTION V. All ordinances or parts of ordinances inconsistent herewith are repealed.

AN ORDINANCE OF THE TOWNSHIP OF PLUMSTED, COUNTY OF OCEAN, STATE OF NEW JERSEY AMENDING CHAPTER 19-6.3 OF THE GENERAL ORDINANCES OF THE TOWNSHIP OF PLUMSTED, ENTITLED "DUTIES AND POWERS OF THE FLOODPLAIN ADMINISTRATOR"

WHEREAS, the Township of Plumsted is required, pursuant to N.J.A.C. 5:23 et seq., to administer and enforce the State building codes, and such building codes contain certain provisions that apply to the design and construction of buildings and structures in flood hazard areas; and

WHEREAS, it is the desire of the Township Committee to appoint a Floodplain Administrator who is qualified and certified which is not restricted to appointing the Zoning Officer.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Plumsted, County of Ocean, State of New Jersey, that the following floodplain management regulations are hereby adopted, as follows:

SECTION 1. The foregoing whereas clauses are incorporated herein by reference and made a part hereof.

SECTION 2. These regulations specifically amend Chapter 19-6.3 of the General Ordinances of the Township of Plumsted entitled "Duties and Powers of the Floodplain Administrator," which shall read as follows:

§19-6.3. Duties and Powers of the Floodplain Administrator.

- A. Floodplain Administrator Designation. The Plumsted Township Zoning Officer, *or any other qualified employee* is designated as the Floodplain Administrator. The Floodplain Administrator shall have the authority to delegate performance of certain duties to other employees.
- B. [no change]
- C. Coordination. The Floodplain Administrator shall coordinate with the Construction Official and Zoning Officer, if not the appointed Floodplain Administrator, to administer and enforce the flood provisions of the Uniform Construction Code.

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by a Court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 4. Since this ordinance is legislative in nature, there shall be the codification of same in the General Ordinance Book of the Township of Plumsted.

SECTION 5. This ordinance shall take effect after second reading and publication as required by law.



Accident Support Team, F.A.S.T.) By the Ocean County Prosecutor's Office (hereinafter referred to as "Prosecutor's Program") for the purpose of assisting in the investigation, prosecution of fatal accidents and in traffic enforcement and education; and

WHEREAS, the Prosecutor's Program receives funding from the County of Ocean; and

WHEREAS, the Prosecutor's Office and the Municipality have determined it to be in their mutual interest for the Municipality to designate certain police officers to be assigned to Prosecutor's Program; and

WHEREAS, the shared Services Act, N.J.S.A. 40:8A-1 et seq., authorizes local units as defined in the Act to enter into joint agreements for the provision of governmental services; and

WHEREAS, the Municipality wishes to enter into an Agreement with the County for the purpose of setting forth the terms and conditions regarding the assignment of police officers employed by the Municipality to the Prosecutor's Program

NOW, THEREFORE, in consideration of the mutual covenants and conditions hereinafter set forth pursuant to the authority provided by law, the parties hereby agree to and with each other as follows:

DESIGNATION OF POLICE OFFICERS FOR ASSIGNMENT TO PROSECUTOR'S
 PROGRAM. Upon request by the County, the Municipality shall designate those officers to be assigned to the PROSECUTOR'S PROGRAM and shall provide the County with a list of those officers.

- 2. **RESPONSIBILITIES OF MUNICIPALITY.** The Municipality agrees that it shall have the following responsibilities during the term of this Agreement:
 - (a) The Municipality will provide department in-service training to those officers assigned to the Prosecutor's Program.
 - (b) The Municipality will be responsible for conducting weapons qualifications for those officers assigned to the Prosecutor's Program.
- 3. **RESPONSIBILITIES OF COUNTY.** The County agrees that it shall have the following responsibilities during the term of this Agreement.
 - (a) The County will forward to the Municipality a schedule of any training attended by or instructed by the officers assigned to the Prosecutor's Program.
 - (b) The County shall provide the Municipal Police Department with information on current Prosecutor's Program activities within the Municipality during scheduled briefings.
- 4. **COMPENSATION.** The County shall pay the officers department at the rate of fifty- five (\$55.00) per hour for their performed hereunder, with a minimum of four hours per callout. Upon exceeding four hours officers will be compensated for each additional hour worked at the aforementioned rate. It is the responsibility of the individual officer's department to pay any income tax or other taxes required to be paid from their salary received pursuant to this agreement.
- 5. **TERM.** This Agreement shall be retroactive from January 1, 2023 and shall continue in full force and effect until December 31, 2023.
- 6. **TERMINATION.** Either party to this Agreement may, be giving written notice to the other party, terminate this Agreement.
- 7. **RELATIONSHIP OF PARTIES.** The officers assigned to the Prosecutor's Office pursuant to this Agreement are not and shall not be considered agents or employees of the County.
- 8. VIOLATIONS OF RULES AND REGULATIONS OF THE MUNICIPAL POLICE

 DEPARTMENT. During the time of their assignment to the Prosecutor's Office, the officers shall continue to be governed by the rules and regulations of the Municipal Police Department.

In the event of any violation of the said rules and regulations, the officer committing the violation may be returned to the Municipal Police Department for appropriate disciplinary action.

- 9. VIOLATIONS OF RULES AND REGULATIONS OF PROSECUTOR'S OFFICE. The Prosecutor's Office shall assume responsibility for the actions of the officers during the period of their service in the Prosecutor's Program and shall handle disciplinary action for the violation of the rules and regulations of the Prosecutor's Office. In its discretion, the Prosecutor's Office shall investigate any alleged violations of its rules and regulations and violations of public trust. The Prosecutor's Office shall file a written report of any alleged violations with the Chief of Police of the Municipal Police Department, along with a report of the investigation, any conclusions reached and subsequent disciplinary action, if any.
- 10. ASSIGNABILITY. The Municipality shall not assign or transfer any of the work or services to be performed hereunder of any other interest in this Agreement without the prior written approval of the County.
- 11. **ENTIRE AGREEMENT,** This Agreement contains the entire Agreement between the parties and no modification hereof shall be effective unless in writing, signed by the party to be charged therewith. This Agreement shall supersede any other understanding or correspondence that may have been exchanged between the parties on the subject matter hereof.
- 12. **BINDING EFFECT.** This Agreement has been duly entered into and constitutes a legal, valid and binding obligation of the County and the Municipality, enforceable in accordance with its terms, and it shall inure to the benefit of the parties hereto and their successors and assigns.

The Governor's Council on Alcoholism and Drug Abuse (GCADA) has announced its intention to provide a grant to Ocean County to continue funding for the Municipal Alliance Program.

According to the funding formula, Plumsted is eligible to receive approximately \$7,987.00 in DEDR funds with a Cash Match requirement of \$1,996.75 and an In-Kind requirement of \$5,990.25 for State fiscal year 2024, starting July 1, 2023 through June 30, 2024. All funds are contingent upon receipt of grant funds from the Governor's Council on Alcoholism and Drug Abuse and approval by the Ocean County Board of Health.

SYNOPSIS

Increases amount annually credited to Shore Protection Fund to \$50 million.

CURRENT VERSION OF TEXT

As introduced.

AN ACT increasing the annual amount deposited in the Shore Protection Fund from the realty transfer fee and amending P.L.1968, c.49.

BE IT ENACTED by the Senate and General Assembly of the State of New Jersey:

- 1. Section 4 of P.L.1968, c.49 (C.46:15-8) is amended to read as follows:
- 4. a. The proceeds of the fees collected by the county recording officer, as authorized by P.L.1968, c.49 (C.46:15-5 et seq.), shall be accounted for and remitted to the county treasurer.
- b. (1) The county portion of the basic fee collected pursuant to paragraph (1) of subsection a. of section 3 of P.L.1968, c.49 (C.46:15-7) shall be retained by the county treasurer for the use of the county.
- (2) The State portion of the basic fee, the additional fee, and the general purpose fee shall be paid to the State Treasurer for the use of the State. Payments shall be made to the State Treasurer on the tenth day of each month following the month of collection.
- c. (1) Amounts, not in excess of [\$25,000,000] \$50,000,000, paid during the State fiscal year to the State Treasurer from the payment of the State portion of the basic fee shall be

credited to the "Shore Protection Fund" created pursuant to section 1 of P.L.1992, c.148 (C.13:19-16.1), in the manner established under that section.

- (2) In addition to the amounts credited to the "Shore Protection Fund" pursuant to paragraph (1) of this subsection, amounts equal to \$12,000,000 in each of the first 10 years after the date of enactment of the "Highlands Water Protection and Planning Act," P.L.2004, c.120 (C.13:20-1 et al.) and to \$5,000,000 in each year thereafter, paid during the State fiscal year to the State Treasurer from the payment of fees collected by the county recording officer other than the additional fee of \$0.75 for each \$500 of consideration or fractional part thereof recited in the deed in excess of \$150,000 shall be credited to the "Highlands Protection Fund" created pursuant to section 21 of P.L.2004, c.120 (C.13:20-19), in the manner established under that section. No monies shall be credited to the "Highlands Protection Fund" pursuant to this paragraph until and unless the full amount of [\$25,000,000] \$50,000,000 has first been credited to the "Shore Protection Fund" pursuant to paragraph (1) of this subsection.
- (3) In addition to the amounts credited pursuant to paragraphs (1) and (2) of this subsection, commencing with the first State fiscal year next following the enactment of P.L.2021, c.126, an amount equal to \$20,000,000 shall annually be credited to the Special Needs Housing Trust Fund, created pursuant to section 1 of P.L.2005, c.163 (C.34:1B-21.25a), in the manner established under that section.
- d. All amounts paid to the State Treasurer from the payment of the additional fee shall be credited to the Neighborhood Preservation Nonlapsing Revolving Fund established pursuant to P.L.1985, c.222 (C.52:27D-301 et al.), in the manner established under section 20 thereof (C.52:27D-320).

(cf: P.L.2021, c.126, s.1)

2. This act shall take effect immediately and shall apply only to State fiscal years beginning after the enactment of this act.

STATEMENT

This bill increases from \$25 million to \$50 million the amount that is annually credited to the Shore Protection Fund from the collection of realty transfer fees.

The realty transfer fee is imposed on the recording of deeds transferring real property, and is calculated on the basis of the amount paid in the deed. The basic rate is \$1.75 for each \$500 of consideration, of which \$0.50 is retained by the county and \$1.25 is the State share. Currently, the first \$25 million of the State share collected annually is credited to the Shore Protection Fund.
