There was a discussion about the length of time to allow for abandoned vehicles. Also, discussed was the definition of an abandoned vehicle. Attorney Kelly talked about it being a code ordinance with a front-yard setback and the requirement for vehicle registration. It was agreed that the ordinance would be amended to read three months instead of six.

Trotta said the next ordinance is 2018-20 which has to do with an increase in dog registration fees. CFO Madden spoke about the dog trust account and the rationale for the increase. Jennifer Witham also talked about the need to enforce the law and follow up with court summonses for unlicensed dogs. There was a discussion and the committee agreed to increase the fees for dog licenses. They also agreed that enforcement needs to be researched further.
