The Workshop Session of the meeting of the Plumsted Township Committee was called to order by Mayor Trotta.

**STATEMENT:** "This meeting is being held in compliance with the Open Public Meetings Act. It was advertised for publication in the Asbury Park Press and posted on the bulletin board."

Committeeman Lotito was not in attendance.

Mayor Trotta asked everyone to rise for the flag salute and then there was a moment of silence.

Trotta reviewed the agenda. There were presentations for tonight. Trotta said, after a vote, we hope to appoint a full-time police officer and a Class II part-time police officer. We will be recognizing our fireworks contributors and volunteers. Trotta also advised there is a second reading and public hearing on two ordinances today, the salary ordinance that is revised as needed and the ordinance to freeze longevity for administrative employees.

There is an ordinance for introduction for bamboo as we've discussed in the past. Committeeman Marinari spoke about the ordinance. There is a question about maintaining weeds and specifically bamboo. Marinari felt this ordinance will do what it needs to be done. He stated that whatever the committee thinks, they can vote as they wish. Marinari feels it will help with bamboo and other weeds that are invasive. Trotta questioned the identification of the species. There are several types of species, not all of which are invasive. How will we identify it properly? Marinari commented it could be sent to the agriculture department who has a couple week turnaround time.

Marinari also brought up the issue of who will be maintaining the grounds. If we were to go with a person on our own next year to maintain the grounds, perhaps we should hire someone who could identify possible invasive species or have that person trained to do so. There are classes at Rutgers to learn about species. Marinari advised Animals and Gardens Unlimited called him to identify something over the phone which would be too difficult. Invasive bamboo is relatively easy to identify and Marinari would be happy to help with that.

Rutgers would charge for us to identify it. Mayor Trotta spoke about revising the ordinance to include any fees incurred would be the responsibility of the species identification. Attorney Kelly will add that to the ordinance. Plumsted has had two complaints to date. It is unsure if this will be an issue for any other residents.

The ordinance may still be introduced tonight but will be amended to add that wording for identification and cost. Deputy Mayor Sorchik clarified this ordinance is about all invasive plants, not just bamboo.

Committeeman Jones is concerned about the identification and the time taken away from Leutwyler if he has to enforce the ordinance. He feels that Leutwyler has a lot of responsibilities and it may require hiring another individual for that that specific job. Mayor Trotta asked the committee; it will be introduced as amended.

Trotta went through the rest of the agenda. He reviewed the resolutions. Also advised we would be interviewing two officers to hire tonight. And the other reports will be voted upon.

Committeeman Marinari spoke about the bill list. He will vote no on 18-00192 for Total Lawn Care and Landscaping for \$4475. He continues to have concerns about what was done for that amount. The fields may not have been cut as requested.

Deputy Mayor Sorchik advised that the safety inspections were passed by the JIF throughout the municipality and he thanked Leutwyler and Witham.

Trotta asked if there were any other comments. There were none.

Attorney Kelly read Resolution No. 2018-247 for Executive Session. The following matters will be discussed: under personnel - interviews; under contractual - landscape terms; and under potential litigation – Rt 537/Hawkin Rd traffic signal problems and Jacobstown Road.

Marinari asked if there was a certificate for them to purchase it; he believed they did. Leutwyler will look into it. Trotta also mentioned 18-00643 for New Egypt Electric for repairing lights on the football field. He doesn't know if this is the same issue or a second one. Trotta wants to be sure it isn't a separate issue. Leutwyler will look into it as well.

Mayor Trotta asked for any old business from the committee. Committeeman Marinari brought up the wrestling posters that are all over town. Were they the same company? Leutwyler discussed. Marinari said they are on Rt. 539 and also at the Marketplace. If it is the same individuals as last year, then something should be done. Trotta agreed. There is a big, possibly wood sign, high up on the ground on the pole on Main Street. Trotta said on 539, there is an island near Nova Tile, they have one right there and it should be removed. There are two on 539 & 528.

Committeeman Marinari reached out to Superintendent North about setting up another meeting, still waiting to hear back from him.

Deputy Mayor Sorchik advised that we got our acceptance and compliance letter from the RERP, Radiological Emergency Response Plan. OEM and the Police Department applied for a grant and were successful. The township got two radios, about \$15,000 total and 160 traffic cones for \$2500. That's from the operating expense of Oyster Creek, not county tax dollars. He congratulated Linda Salcfas, Chief Meroney and his staff.

Committeeman Jones wanted to say that with summer coming to a close, kids are off to school tomorrow so watch buses and drop off of students. He thanked first responders for an incident at football. A football player was choking, 911 was called and the ambulance was there within 2 minutes. Apparently the boy had a seizure but thankfully the ambulance took care of him. He was very happy about that. A week later, he was home. His neighbor across the street needed an ambulance. Jones lives on the other side of Plumsted and said that it was maybe 5 minutes and the ambulance was there. Finally, Jones said he went to a lot of summer parties and he never saw so many lifeguards that were hired to watch the kids in the pool. He was happy to see that as well.

Public Safety Director Wendy Galloway said that he will be sure to have the sign at the Marketplace and Sweet Carolina to reflect school is in session and be mindful of buses and students. Witham added that it was showing this afternoon on that electronic sign.

Committeeman Marinari spoke to the Environmental Commission and said there is \$300 in the Sustainable NJ budget. His recommendation is to take that money out as they really haven't gotten that going.

Mayor Trotta said that Irina Darrar is here tonight. She will be working part time in the clerk's office and the construction office, and will serve as the Land Use Board secretary as well. Patricia Starzynski is also in attendance. She was appointed tonight to work full time in the construction office.

Trotta asked if there was any other public comment. Mayor of Upper Freehold Township, Steve Alexander came forward. He wanted to thank the township for the attempted help in the summer with their school security. Plumsted acted with much consideration to a neighboring town. On behalf of Upper Freehold, as well as the BOE, thank you. It meant a lot to them when they needed help. It didn't work out because of the statute but they appreciate it. Monmouth County Sheriff's Office will be able to help them now. He also thanked Chief Meroney and said that we are fortunate to have him.

Mayor Trotta asked for any other public comment; there was none.

Mayor Trotta asked if there was any further business. There was none.
