RESOLUTION OF THE PLUMSTED MUNICIPAL UTILITIES AUTHORITY REJECTING ALL BIDS FOR THE PROPOSED NEW EGYPT DOWNTOWN SANITARY SEWER COLLECTION AND DISPOSAL SYSTEM

WHEREAS, nine (9) bidders submitted bids for this project with a low bid of \$25,831,217.00 to a high bid of \$44,484,101.29; and

WHEREAS, pursuant to <u>N.J.S.A.</u> 40A:11-13.2, a contracting unit may reject all bids if the lowest bid substantially exceeds the cost estimates for the goods or services and/or the lowest bid substantially exceeds the contracting units appropriations for the goods or services or the contracting unit wants to substantially revise the specifications for the goods or services; and

WHEREAS, for each of these three (3) separate reasons, the Plumsted Municipal Utilities Authority has determined to reject all bids received on May 23, 2018; and

NOW, THEREFORE, BE IT RESOLVED, this 19th day of June, 2018, by the Plumsted Municipal Utilities Authority that the Authority hereby rejects all bids submitted for the New Egypt Downtown Sanitary Sewer Collection and Disposal System which bids were submitted on May 23, 2018; and
