

ORDINANCE NO. 2020-06

**ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE
TOWNSHIP OF PLUMSTED, COUNTY OF OCEAN, STATE OF
NEW JERSEY, AMENDING ORDINANCE 2017-17 ADOPTING A
SANITARY SEWER MANDATORY HOOKUP REQUIREMENT TO
BE SET FORTH IN THE RULES AND REGULATIONS OF THE
PLUMSTED MUNICIPAL UTILITIES AUTHORITY**

SECTION 1: Whereas the Township of Plumsted, County of Ocean, State of New Jersey (hereinafter referred to as the "Township") has previously established the Plumsted Municipal Utilities Authority (hereinafter referred to as the "Authority");

SECTION 2: Whereas the Authority has the general responsibilities and obligations concerning the sanitary sewer installation and maintenance throughout the Township;

SECTION 3: Whereas the Authority has proposed rules and regulations governing the installation of sanitary sewers throughout portions of the Township;

SECTION 4: Ordinance No. 2017-07 adopted a sanitary sewer mandatory hookup requirement to be set forth in the Rules and Regulations of the Plumsted Municipal Utilities Authority; and

SECTION 5: The per diem fine for a property owner failing to make a connection to the sewer system is \$100 which shall be enforceable in the Municipal Court.

NOW THEREFORE BE IT ORDAINED, by the Township Committee of the Township of Plumsted, County of Ocean and State of New Jersey as follows:

1. The per diem fine for a property owner failing to make a connection to the sewer system is \$100 which shall be enforceable in the Municipal Court.
2. All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.
3. If any Section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the Section, paragraph, subdivision, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.
4. This Ordinance shall take effect after final passage, adoption and publication according to law.




