**RESOLUTION OF THE PLUMSTED MUNICIPAL UTILITIES
AUTHORITY AUTHORIZING AN AMENDMENT TO THE
AUTHORITY'S CONTRACT WITH T&M ASSOCIATES WITH
RESPECT TO HOURLY INSPECTION FEES**

WHEREAS, the Plumsted Municipal Utilities Authority (hereinafter referred to as "Authority") has previously entered into a contract with T&M Associates with respect to the development of its' proposed sewer treatment plant; and

WHEREAS, in accordance with that contract, T&M Associates has subcontracted certain services to Natural Systems Utilities (NSU); and

WHEREAS, said subcontractor has advised that, since the time the original contracts were awarded, additional inspections will now be required pursuant to regulations of the State of New Jersey; and

WHEREAS, NSU has agreed to perform those services at the rate of one-hundred ten dollars (\$110.00) per hour; and

WHEREAS, said cost exceeds the amount originally authorized pursuant to the contract with T&M Associates; and

WHEREAS, as a result, the Authority hereby authorizes an increase in the amount of \$306,282.00 to its' contract with T&M Associates; and

WHEREAS, the Authority wishes to authorize the inspection fee of one-hundred ten dollars (\$110.00) per hour for NSU; and

NOW, THEREFORE, BE IT RESOLVED, this ____ day of _____, 2020, by the Plumsted Municipal Utilities Authority, that the Authority hereby authorizes an amendment to the contract with T&M Associates to provide for inspection fees in the amount of one-hundred ten dollars (\$110.00) per hour to NSU, T&M Associates subcontractor;
