RESOLUTION OF THE PLUMSTED MUNICIPAL UTILITIES AUTHORITY AUTHORIZING AN INCREASE IN THE CONTRACT BETWEEN THE PLUMSTED MUNICIPAL UTILITIES AUTHORITY AND KLEINFELDER, LLC

WHEREAS, pursuant to Resolution 2020-16, the Plumsted Municipal Utilities Authority (hereinafter referred to as "Authority") authorized Kleinfelder, LLC, to proceed with Phase I of three (3) proposed phases of its study to assess the likelihood of the Authority obtaining certain permit modifications to its NJDEP permit at a cost not to exceed \$16,000.00; and

WHEREAS, pursuant thereto, Kleinfelder, LLC, has had discussions with representatives of the New Jersey Department of Environmental Protection, and believes it would be appropriate for the Authority to pursue Phase II of this project, and has requested the Authority authorize Kleinfelder, LLC, to proceed with same at a cost not to exceed \$35,000.00; and

WHEREAS, Mr. Raymond Ferrara of Kleinfelder, LLC, provided updates to the Authority with respect to his efforts on April 21, 2020, at which time the Authority chose not to proceed to Phase II; and

WHEREAS, the Board determined to hold a special meeting on May 6, 2020, to reconsider whether it would authorize Phase II of the study to be completed; and

WHEREAS, the Authority did, on May 6, 2020, determine to authorize Phase II of the study to be prepared by Kleinfelder, LLC; and

WHEREAS, this Resolution is contingent upon a certification of funding being available from the Township's CFO, June Madden; and

NOW, THEREFORE, BE IT RESOLVED, this _____ day of ________, 2020, by the Plumsted Municipal Utilities Authority, that the Authority hereby authorizes Kleinfelder, LLC, to proceed with Phase II of its study to obtain certain modifications to its NJDEP permit at a cost not to exceed \$35,000.00; and
