WHEREAS, additional professional service fees in the amount of \$20,764.00 will be used to ensure all items required by Task 4 are completed in accordance with NJDEP/NJIB Funding Requirements and include additional hours to properly conduct all aspects of administering the contract which will include construction administration of approximately six (6) hours per week through August, 2020, and the preparation and attendance of up to six (6) additional subcommittee meetings for the duration of the collection system contract; and

WHEREAS, T&M Associates further requests an amendment to cover an additional 480 hours of inspection time as outlined in their March 24, 2020, letter to the Authority; and
