RESOLUTION OF THE PLUMSTED MUNICIPAL UTILITIES AUTHORITY AUTHORIZING AN INCREASE IN THE AUTHORITY'S CONTRACT WITH P&A CONSTRUCTION, INC. IN THE AMOUNT OF \$12,755.00 TO COVER NIGHT UNIT PRICING FOR NIGHT WORK

**WHEREAS,** the Plumsted Municipal Utilities Authority has previously entered into a contract with P&A Construction, Inc., for the construction of a waste water collection system within Plumsted Township and in accordance with an agreement with the PMUA; and

WHEREAS, during the course of the contract it was determined that certain work would need to be performed at night to assist the local businesses in the community who would suffer a hardship during regular business hours if the work was performed at that time; and

**WHEREAS**, this resulted in an increase in the night unit price for various materials with a total additional cost for night work being \$12,755.00 above and beyond the original day total of \$26,974.17; and

**WHEREAS**, the Authority's consulting Engineer, T&M Associates, has recommended to the Authority that it authorizes the increase in the contract price in the amount of \$12,755.00 to the contractor; and

WHEREAS, the Authority wishes to accept the recommendation of its Engineer; and

**WHEREAS**, this Resolution is specifically contingent upon a certification of funds being made available by the Treasurer; and
