RESOLUTION OF THE PLUMSTED MUNICIPAL UTILITIES AUTHORITY AUTHORIZING THE EXTENSION OF AN EXISTING CONTRACT BETWEEN THE PLUMSTED MUNICIPAL UTILITIES AUTHORITY AND T&M ASSOCIATES FOR THE DESIGN AND CONSTRUCTION OF THE WASTE WATER TREATMENT PLANT FOR THE TOWNSHIP OF PLUMSTED PURSUANT TO N.J.S.A. 40A:11-15(9)

WHEREAS, the Plumsted Municipal Utilities Authority has previously entered into a contract with T&M Associates as a Special Projects Engineer to design, construct and oversee the development of a waste water treatment facility within the Township of Plumsted; and

WHEREAS, said contract ran for a period of five (5) years and was originally awarded in 2015; and

WHEREAS, pursuant to N.J.S.A. 40A:11-15, the Authority is permitted to authorize a contract for a single project for the construction of any public building, structure or facility for such length of time as authorized and necessary for the completion of the actual construction; and

WHEREAS, it is the intention of this Resolution to authorize an extension to the existing contract between the Authority and T&M Associates for the design and construction of the Township's waste water treatment facility currently under construction; and

NOW, THEREFORE, BE IT RESOLVED, this 21st day of July, 2020, by the Plumsted Municipal Utilities Authority, that the Authority hereby authorizes an extension of the existing contract with T&M Associates for the design, construction and development of a waste water treatment facility within the Township of Plumsted for a period of five (5) years from the date of this Resolution, or until such time as the facility is in full operation, whichever event occurs sooner; and
