**RESOLUTION OF THE PLUMSTED MUNICIPAL UTILITIES  
AUTHORITY AUTHORIZING THE AUTHORITY TO  
ADVERTISE FOR AND RECEIVE PROPOSALS FOR  
ENGINEERING SERVICES EXEMPT FROM THE PUBLIC  
BIDDING PROCESS**

**WHEREAS**, the Plumsted Municipal Utilities Authority is desirous of receiving proposals for general engineering services, which services are exempt from the public bidding process of the New Jersey Local Public Contracts Law; and

**WHEREAS**, said services are subject to the Campaign Finance Reform Act as set forth in N.J.S.A. 19:44A-20.5 and shall be awarded under the Open & Fair Process outlined in N.J.S.A. 19:44A-20.1 et seq.; and

**WHEREAS**, the Authority shall use the following criteria with respect to said proposals:

- a) Name and business address of proposed contractor;
- b) Experience, which includes evidence of similar services for similar entities;
- c) Description of the ability to provide the services in a timely fashion;
- d) Cost details including the hourly rate for each individual who will perform services;
- e) Qualifications of the individuals who will perform the tasks;
- f) Such other relevant experience as may be deemed necessary; and

**WHEREAS**, proposals by vendors shall be sealed and opened at a time certain as determined by the Executive Director, and such proposals shall become available to the public at that time; and

**NOW, THEREFORE, BE IT RESOLVED**, this 21st day of July, 2020, by the Plumsted Municipal Utilities Authority as follows:
