RESOLUTION OF THE PLUMSTED MUNICIPAL UTILTIES AUTHORITY AUTHORIZING A CHANGE ORDER # 7 TO "TASK 4" BIDDING AND CONSTRUCTION ADMINISTRATION IN ACCORDANCE WITH THE CONTRACT BETWEEN THE AUTHORITY AND T&M ASSOCIATES

WHEREAS, the Plumsted Municipal Utilities Authority has previously entered into a contract with T&M Associates to perform certain consulting engineering services for the Authority's Downtown Sanitary Sewer Collection and Disposal System; and

WHEREAS, in accordance with the contract entered into between the parties, T&M Associates requires authorization from the Plumsted Municipal Utilities Authority to commence additional tasks as they become necessary; and

WHEREAS, the Authority has now received a Treatment Works Approval from the New Jersey Department of Environmental Protection for the proposed pump station and wastewater treatment plant as well as various other necessary approvals from State and County Agencies; and

WHEREAS, the Authority has previously authorized T&M Associates by Resolution 2018-02 to commence "Task 4", Bidding and Construction Administration, of the contract for a total amount of \$137,560.00; and

WHEREAS, T&M has had to expend additional resources that were not anticipated in their original proposal and has requested the Authority to authorize an additional not to exceed \$10,200.00 to complete this necessary work (see Attachment 1) for a total cost of \$147,760.00; and

WHEREAS, this authorization is subject to the availability of funds and authorization to go out to bid pursuant to the New Jersey Environmental Infrastructure Trust Fund; and
