**RESOLUTION OF THE PLUMSTED MUNICIPAL UTILITIES  
AUTHORITY AUTHORIZING A CHANGE ORDER # 7 TO  
“TASK 4” BIDDING AND CONSTRUCTION  
ADMINISTRATION IN ACCORDANCE WITH THE  
CONTRACT BETWEEN THE AUTHORITY AND T&M  
ASSOCIATES**

**WHEREAS**, the Plumsted Municipal Utilities Authority has previously entered into a contract with T&M Associates to perform certain consulting engineering services for the Authority’s Downtown Sanitary Sewer Collection and Disposal System; and

**WHEREAS**, in accordance with the contract entered into between the parties, T&M Associates requires authorization from the Plumsted Municipal Utilities Authority to commence additional tasks as they become necessary; and

**WHEREAS**, the Authority has now received a Treatment Works Approval from the New Jersey Department of Environmental Protection for the proposed pump station and wastewater treatment plant as well as various other necessary approvals from State and County Agencies; and

**WHEREAS**, the Authority has previously authorized T&M Associates by Resolution 2018-02 to commence “Task 4” , Bidding and Construction Administration, of the contract for a total amount of \$137,560.00; and

**WHEREAS**, T&M has had to expend additional resources that were not anticipated in their original proposal and has requested the Authority to authorize an additional not to exceed \$10,200.00 to complete this necessary work (see Attachment 1) for a total cost of \$147,760.00; and

**WHEREAS**, this authorization is subject to the availability of funds and authorization to go out to bid pursuant to the New Jersey Environmental Infrastructure Trust Fund; and

**NOW, THEREFORE, BE IT RESOLVED** this 27th day of March, 2018 the Authority authorizes Change Order #7 related to Task 4 to T&M Associates in accordance with the terms and conditions set forth in this Resolution.

**BE IT FURTHER RESOLVED** that a copy of this Resolution be forwarded to T&M Associates, Plumsted Township Land Use Board, Plumsted Township CFO and the Township Clerk by the Municipal Utilities Authority Secretary.
