RESOLUTION OF THE PLUMSTED MUNICIPAL UTILITIES AUTHORITY AUTHORIZING THE ACCEPTANCE AND EXECUTION OF AN EASEMENT AGREEMENT WITH TOOTIES HOME COOKING INC. WITH RESPECT TO A PORTION OF LOT 5 IN BLOCK 38
