**RESOLUTION OF THE PLUMSTED MUNICIPAL UTILITIES  
AUTHORITY AUTHORIZING THE ADVERTISEMENT FOR  
BIDS FOR WASTE WATER TRANSPORTATION FOR THE  
PLUMSTED MUNICIPAL UTILITIES AUTHORITY**

**WHEREAS**, the Plumsted Municipal Utilities Authority is currently constructing a waste water treatment plant and collection system in the downtown New Egypt area of Plumsted Township; and

**WHEREAS**, it is anticipated that the waste water treatment system will be operational in approximately the middle of 2021; and

**WHEREAS**, until such time as the waste water system is fully operational, the Plumsted Municipal Utilities Authority is obligated by contract to provide a temporary sludge holding tank to be located at 947 Monmouth Road; and

**WHEREAS**, in accordance with contractual obligations, the Plumsted Municipal Utilities Authority is obligated to transport domestic solid waste from the temporary sludge holding tank to the Bordentown Sewage Authority; and

**WHEREAS**, the Authority wishes to advertise for the receipt of bids for this service in accordance with the New Jersey Local Public Contracts Law; and
