All officers working in accordance with the DDEF Grant shall be paid at their overtime rate. All officers working in accordance with State and Federal Grants, with the exception of DDEF, will be paid at the rate of \$50 per hour. Allentown Court Security is paid at \$50 per hour with a three (3) hour minimum of \$150.
