The Workshop Session of the meeting of the Plumsted Township Committee was called to order by Mayor Trotta.

**STATEMENT:** "This meeting is being held in compliance with the Open Public Meetings Act. It was advertised for publication in the Asbury Park Press and posted on the bulletin board."

Mayor Trotta said Committeeman Wysong was excused.

Mayor Trotta called the meeting to order and it was opened with the Flag Salute. The invocation was led by Pastor Zoon of the New Egypt Presbyterian Church. Committeeman Marinari asked for a moment of silence as 75 years ago on this day our nation entered one of its most perilous times losing over 2,400 men and women at Pearl Harbor with many more lives being lost for our nation among during World War II.

Mayor Trotta reviewed the evening's agenda. The first item was regarding abandoned properties, Trotta asked Attorney Kelly to discuss the proper process for the Township receiving reimbursement when work is done on abandoned properties. Attorney Kelly explained the ordinance. There was also discussion regarding an enforcement action and penalties which is a different issue under the Property Maintenance Ordinance.

Committeeman Lotito questioned some of the language, Attorney Kelly noted that Plumsted is unique from other municipalities and what may be overgrown in a suburban neighborhood with many homes is not the same as overgrowth you would see in a field. He said it would be up to the discretion of the Code Enforcement Officer whether that would be an issue. Kelly advised this has to do with the health, safety and welfare of the community.

Administrator Dancer said that the language came directly from the State Statute which would have a better degree of enforcement by the court. Dancer advised when citing the Municipal Ordinance, the fines and penalties should be cited as well. He noted State Statute 40:48-2.13 (Ordinance authorizing removal destruction of brush, leaves, debris, etc). Dancer said the important part was "ordinance authorized: The governing body of every municipality shall have the power to make, enforce, amend and appeal ordinances requiring the owner or tenant ... ", but the important thing was the State has provided that authority to the municipality to adopt an ordinance and follow the contracts law in getting quotes, etc.

Mr. Leutwyler said that normally with the notices he sends out, the letter states either it needs to be cleaned up within ten days or contact him. He said he has had success with people calling him and asking for additional time. The ones he issued summons to were ones he was unable to get a hold of. Leutwyler has been fortunate enough to work with residents.

Committeeman Marinari felt there should be one individual, not two or three, trying to do the same thing as this could cause a major issue.

Mayor Trotta said the Township has been slow in reacting because they want to give everyone the benefit of the doubt. It is the ones that don't answer that are the problem and it is not fair to the community.

Deputy Mayor Sorchik questioned Attorney Kelly regarding the ordinance and asked if the Township has the ability to hire an outside contractor and would we be using our maintenance people. Sorchik had some concern regarding liability if we have a Township employee on private property. If something went wrong, what would be the Township's liability. If we had a contractor and they are insured, then it would be their liability. He wanted to make the Joint Insurance Fund knows the Township was doing this and would only encourage this as a last resort. He felt much more comfortable hiring a contractor if that is the case. Sorchik said this was discussed a few years ago and at that time we were not going to send our own people simply for that reason so that the person in violation could create havoc. It was discussed but wasn't sure if they came to a resolution.

Mayor Trotta said the next item for discussion was the Grounds Maintenance Contract to maintain the fields at the recreation field, municipal building and downtown area with Ron Tabor. The contract can be renewed for one more year. A letter will be sent indicating that the Township will be extending his contract for another year. He has been doing a good job and there haven't been any issues with the sports.

Mayor Trotta said there was a draft ordinance for marriage fees. The previous mayor suggested a long time ago that the Township should charge a fee for performing marriages. The fee is \$50 for township residents, \$100 for non-residents, and then if travel was involved there is fee for mileage. It was noted that this ordinance is similar to other municipalities. There was discussion regarding the fees. Administrator Dancer said with respect to Section 1-D, where it says that said fees shall be payable at the

time of the ceremony, he checked the Local Finance Board for guidance and they have a Local Finance Notice 2075 which says that all disbursements to the Mayor must be pursuant to the ordinance adopted by the municipality for a fixed fee for the service provided by the Mayor or reimbursement with out of pocket expenses. The fee must be payable to the municipality, deposited into the Current Fund and then disbursed to the Mayor through appropriate budget line item. What the procedure is for the first year is that "in all cases fees collected for the performance of marriages and civil union ceremonies must be deposited into the Current Fund as MRNA (Miscellaneous Revenue Not Anticipated) unless and until experience would justify anticipation of a separate revenue line item in the Municipal Budget". He suggested to reach out to CFO Madden which Mayor Trotta said he had talked to her and wanted to make it clear that it was not for a salary of the Mayor in any way shape or form. It was just to recoup expenses and the only thing the Mayor or Mayor Emeritus would receive from this would be mileage. The ordinance was amended to read "payable to the Township at the time of the ceremony for clarification so there were no issues.

Municipal Clerk Hendrickson said if they don't collect it at the time of the ceremony, they may not receive it. She said they were going to use Map Quest and figure out the mileage in advance so the couple knows the amount to write on the check ahead of time. Clerk Hendrickson verified with Attorney Kelly if this ordinance could go under the Chapter, Township Committee, which he said yes.

Administrator Dancer also suggested that if the couple wanted to make a contribution to a charity such as the New Egypt First Aid, or Church, etc., we would then check with them first to see if they did. If they didn't, the couple would be advised they could not perform the marriage.

Mayor Trotta said the draft ordinance will be Ordinance No. 2016-18 and will be added to the agenda.

Mayor Trotta wanted to congratulate Ron and Brenda as they were celebrating their 48th Anniversary today.

Mayor Trotta said Resolution No. 2016-299 is a revision of a previous resolution for Officer Doell's time. He noted that his paperwork has been signed but until the Committee receives a release from PERC, the check cannot be dispersed.

Mayor Trotta said at the Land Use Board meeting there was a motion and second to grant a Temporary 2017 renewal license to EME for their annual mining license, which would be Resolution No. 2016-306.

Attorney Kelly read Resolution No. 2016-290.

The Township Committee returned to Open Session. Mayor Trotta called the Regular Session of the meeting to order.

Mayor Trotta read and opened the public hearing on Ordinance No. 2016-15, which establishes salaries for various officials of the Township of Plumsted. He explained that it corrects a few minor issues and to provides for possible raises for the administrative staff. Since there was no public comment, he closed the public hearing.

ROLL CALL VOTE: ALL AYES.

ON MOTION OF DEPUTY MAYOR SORCHIK, SECONDED BY COMMITTEEMAN LOTITO, ORDINANCE NO. 2016-15 WAS ADOPTED. ROLL CALL VOTE: ALL AYES

Mayor Trotta read and opened the public hearing on Ordinance No. 2016-16. He explained that this ordinance amends and supplements Chapter 15, and creates a new section 15:4-14, C-5 Commercial Zone. This area is along Route 539 in the vicinity of East Millstream Road and Hopkins Road creating a C-5 Commercial Zone which is a combination of C-2 and C-3. There was no public comment.

Mayor Trotta asked for any old business from the Committee. There was none.

Trotta asked if there was any new business. Committeeman Marinari wanted to wish everyone best of the Holiday Season no matter how it is celebrated and enjoy the holidays.

Deputy Mayor Sorchik wanted to thank everyone involved in the Tree Lighting Ceremony, the Plumsted Business & Merchants Association, the Girl Scouts who provided cookies, Community Development Coordinator, Arts Council, Municipal Alliance for providing hot chocolate, Peter Ylvisaker and Santa

Claus. He also wanted to thank Rebecca Nowalski for taking pictures, especially the ones with Santa as there were a lot of nice comments.

Committeeman Marinari said there was a combined meeting with members of the Board of Education and Township Committee and this should benefit both the Township and Board, and more importantly the taxpayers, as a dialogue continues.

Committeeman Lotito said the Board of Education gave the Township some PC's and more were expected. He also questioned if there was going to be a Christmas Luncheon for the employees as had been done in the past. It is scheduled for December  $23^{\rm rd}$ .

Administrator Dancer noted that Committeeman Marinari asked that during deer season in New Jersey if there was a program to help the hungry. Marinari said he happened to check the State Division of Fish and Wildlife's website and they established a "hunters helping the hungry" which is a 501C3 which has now partnered with the State Fish and Wildlife. The State of New Jersey gave a legislative grant of \$95,000 to the Division of Fish and Wildlife to initiate the program and then in the second year the Division put in \$50,000 and now there is a list on the website of the approved participating butchers that when the hunters get the deer, they can take it to the approved butchers. Those butchers are then, in turn, giving the venison to approved foodbanks. Committeeman Marinari wished that they would be a little more forth coming in letting the community and hunters know this. Mr. Dancer noted that a total of 433 deer were donated in the 15/16 season which yielded 15,000 pounds of venison for more than 62,000 meals for those in need.

Committeeman Lotito said he had to replace his smoke detectors. Lotito said he did not know that after ten years they needed to be replaced with new ones. He asked if there was something that could be done to notify residents of this. Mayor Trotta suggested we reach out to the Fire Department and see if they could put information out on that.

Mayor Trotta wanted to bring up about the fire at the Canto residence on East Millstream Road. Everyone escaped unharmed; things can be replaced but people cannot. He said it is always touching when you see a community come together to help people in need. Committeeman Marinari said his initial email to Association was that they could draw \$500 from their balance and have that as a credit card to that unfortunate family. He said just within the Association for the family they have over \$2,000 and for the baskets which is normally done, they were able to do 170 baskets which go to the school. The school then dispenses the baskets to families in the community. He said these donations came from small businesses which he thought was amazing.

Dave Leutwyler said the Township employees sponsored a family in need from the school and donated Christmas gifts for the children.

Committeeman Lotito said we sit here and say we were going to earmark money or funds, but he doesn't see it matching the kindness and generosity of people in our town. He was thrilled people did this.

Mayor Trotta also wanted to thank the PBMA for the snowflakes on Main Street for the holiday season, which they bought several years ago. He also stated that one of their members, Jack Wig, installs them at no cost. Committeeman Marinari said they pay \$800 for the electricity for 24 days.

Mayor Trotta said the PBMA is always doing something to help the town and our residents. He encouraged everyone to shop small business all of the time, not just one weekend after Thanksgiving.

Mayor Trotta asked for public comments. There were none. There was no further discussion for the meeting.
