The Workshop Session of the meeting of the Plumsted Township Committee was called to order by Mayor Trotta.

**STATEMENT:** "This meeting is being held in compliance with the Open Public Meetings Act. It was advertised for publication in the Asbury Park Press and posted on the bulletin board."

### THOSE OFFICIALS PRESENT WERE:

COMMITTEEMAN LOTITO COMMITTEEMAN WYSONG CLERK HENDRICKSON COMMITTEEMAN MARINARI DEPUTY MAYOR SORCHIK DAVID LEUTWYLER, CDC MAYOR TROTTA

ATTORNEY KELLY arrived at 7:45.

Mayor Trotta called the Regular Session of the meeting to order with the Flag Salute and Invocation was led by Pastor Cuozzo. Mayor Trotta introduced the professionals at the dais.

Trotta reviewed the agenda. He referred to a memo from CFO June Madden asking the Committee to consider introducing Ordinance 2015-14 regarding worthless checks. The ordinance is to request a change in the fee from \$20 to \$40 for returned checks. The Committee was in agreement.

The "No Knock" ordinance was revisited and compared to our current Peddler's and Solicitor's Ordinance. One difference is that our current ordinance has a permit fee and the Jackson ordinance does not include a fee. The Committee was in agreement to keep our permit fee.

Business Administrator Ron Dancer cited the main difference is that it is voluntary. Residents may request to be placed on a No Knock list, maintained by the police department. Any individual or group requesting a permit would get a copy of the No Knock registry. If the solicitor violates the list and visits a resident against their wishes, the resident can call the township or police department and let them know they were visited by the solicitor. Then it would be determined if the solicitor would receive a fee for ignoring the list. Committeeman Wysong recommends a requirement for the Solicitor to keep a list of those residents he visited. Wysong also brought up the point that charitable and religious organizations are permitted to knock on doors. Does that include school fundraising as they aren't a charitable organization? Committeeman Lotito asked about children having corner lemonade stands. Would they be included? Mayor Trotta said that these were valid points but perhaps it would be better to wait until after the 1st of the year to consider doing the ordinance. Committeeman Wysong asked Attorney Kelly if a violation would hold up in court. Attorney Kelly said that it would be determined on a case-by-case basis as the ordinance hasn't been fully challenged just yet; it is fairly new.

Pastor Cuozzo asked if distributing literature is included in the definition of a peddler or solicitor. Cuozzo said that they do not solicit; they are just looking to leave literature. Attorney Kelly advised that the ordinance should include details as to what is included.

Mayor Trotta said the agenda included Resolution No. 2015-280 to extend the lease with the American Legion for the Municipal Alliance was up for discussion. Resolution No. 2015-285 is a grant for Hopkins Road for improvements for \$250,000.00. Committee Wysong asked where the improvements were beginning and ending. Dancer advised the improvements would begin just prior to Wythe Road where there is a change in the pavement. From that point all the way to and including the curve at Ivins Road. Wysong advised at the corner of Hopkins Rd and Holly Hill Dr that there is a gas plate that should be repaired prior to the road improvements. CDC Leutwyler advised the gas company was notified and are aware of the needed repairs.

Mayor Trotta asked if there were any other items to discuss. Leutwyler said that resident Roy Hendrickson was here to present an eagle painting on loan to be hung at the municipal building. There was discussion about a resolution or artist's agreement being done to protect his art work stating that he is the owner of the painting. Attorney Kelly advised a resolution could be done for him. Clerk Hendrickson advised he presented a pumpkin with a turkey carved in it to the Municipal building on display in the lobby. Trotta advised Resolution 2015-291 would be done by title tonight for Roy Hendrickson and his eagle painting.

Leutwyler asked for discussion about possibly extending the lawn contract with Ron Tabor.

Attorney Kelly read Resolution No. 2015-274 for Executive Session.

Mayor Trotta asked for any old or new business from the Committee.

Mr. Weicberger would like to finish the project by December. All agreed this was an excellent project for our schools and community.

Deputy Mayor Sorchik asked if the Committee got the information from JIF regarding their training at the League. There are two dates. Mayor Trotta said there will also an online option for training.

Mayor Trotta opened the meeting to public comment.

Resident Sherri Lotito of Lauren Lane spoke about her concern for the traffic on Saturday mornings at the bank and Wawa on Main St. There is a traffic tie up because there are no signs for trying to get into the bank. Deputy Mayor Sorchik advised that signage was put up to not block the driveway. Mrs. Lotito said that a problem is that people do not turn right on red, they stop. She wondered if there could be a new sign. Deputy Mayor Sorchik said that would involve Ocean County engineers and a traffic study has already been done in the past. The Committee said that we could ask the County to take a look at it again since it's been a while. Mayor Trotta asked Dave Leutwyler to contact the County.

Resident Leonard Griletto of Highbridge Road, questioned the No Knock Ordinance. He said that there are some items that should be clarified in the Ordinance because he had built his business on going door to door. Mayor Trotta explained the Ordinance.

Resident Barbara Diblin of Terrace Avenue wanted to express her thanks for the sidewalks, gazebo and lighting upgrades in our town. She appreciates everyone's hard work in caring for our town.

The holiday lighting in town was also discussed. They should be up before the lighting of the tree. Committeeman Marinari said the lights cost about \$1800 when they were purchased by the PBMA and the electric is roughly \$900 per year.

Mayor Trotta said there was no further business.
