The Workshop Session of the meeting of the Plumsted Township Committee was called to order by Mayor Trotta.

**STATEMENT:** "This meeting is being held in compliance with the Open Public Meetings Act. It was advertised for publication in the Asbury Park Press and posted on the bulletin board."

Mayor Trotta noted that Committeeman Lotito would not be attending and Committeeman Wysong would be calling in.

Mayor Trotta asked everyone to rise for the Flag Salute and Invocation was led by Pastor Gutacker. Mayor Trotta introduced the professionals at the dais.

Mayor Trotta reviewed the agenda. With respect to the MUA Rules and Regulations and Financial Planning, this will be discussed after Executive Session with Neil Grossman who is the Township's Financial Advisor. There are two ordinances for introduction regarding the Sanitary Sewer Connection Financial Incentive Program and the Sanitary Sewer Mandatory Hookup Requirement. He said also from last month they had an ordinance for the salaries which will be tabled due to another change.

Mayor Trotta said there will be a budget presentation and the authorization for the Township to do a self-examination this year. This has been the first time since Superstorm Sandy that the Township has been able to do this. The budget adoption will also be done which will require four votes, which Committeeman Wysong is scheduled to call in during the Regular Session.

Committeeman Marinari said that with respect to Resolution No. 153 which appoints members to the Municipal Utilities Authority that the Township with regrets accepts the resignation of Harry Miller as he has done a lot for this community. He took over his position when he left the school board and did some very good things and had trying situations during the time when there was no superintendent and then moved on to the presidency. He said he and his wife will be a loss to our community as they are moving.

Attorney Kelly read Resolution No. 2017-146 for Executive Session.

ON MOTION OF COMMITTEEMAN MARINARI, SECONDED BY DEPUTY MAYOR SORCHIK, RESOLUTION NO. 2017-146, AUTHORIZING THE CONVENING OF AN EXECUTIVE SESSION IN ACCORDANCE WITH THE OPEN PUBLIC MEETINGS ACT WAS ADOPTED. ROLL CALL VOTE: ALL AYES AS AMENDED. It was amended to add, under Personnel, the Business Administrator, and Deputy Tax Collector and, under Contractual, the Financial Plan for the MUA.

Mayor Trotta called the Regular Session of the meeting to order. Mayor Trotta noted that if Committeeman Wysong was unable to call in, the Budget Adoption will be tabled.

Mayor Trotta asked Nicole Cronce from the New Egypt Branch of the Ocean County Library to come forward to accept the proclamation for "National Library Week 2017." Committeeman Marinari read and presented the proclamation to Ms. Cronce.

ON MOTION OF DEPUTY MAYOR SORCHIK, SECONDED BY COMMITTEEMAN MARINARI, THE PROCLAMATION PROCLAIMING NATIONAL LIBRARY WEEK 2017 WAS ADOPTED. ROLL CALL VOTE: ALL AYES

Ms. Cronce said they will be celebrating National Library Week for 2017 from April 9<sup>th</sup> to April 15<sup>th</sup> with a pajama story time for children ages 3 to 6 at 6pm. She thanked the Committee for the proclamation and the Committee thanked her for coming.

Mayor Trotta asked Barbara Diblin to come forward to accept the proclamation for National Day of Prayer. Deputy Mayor Sorchik read and presented the proclamation to Ms. Diblin.

ON MOTION OF COMMITTEEMAN MARINARI, SECONED BY MAYOR TROTTA THE PROCLAMATION PROCLAIMING MAY 4, 2017 AS NATIONAL DAY OF PRAYER WAS ADOPTED. ROLL CALL VOTE: ALL AYES

Ms. Diblin said National Day of Prayer will be celebrated in the Municipal Building Court Room from 7:30 to 8:30 on Thursday, May 4<sup>th</sup> and everyone was invited to come. She said there will be leaders that will lead in seven influences in prayer for our nation. She said this was the 25<sup>th</sup> year in Plumsted that this has been done. She presented a short video. The Committee thanked Ms. Diblin for coming.

Mayor Trotta said the next proclamation was for "Paint the Town Pink" for the month of May 2017 and asked if there was someone to accept the proclamation. Kylie from Meridian Health was in attendance and Mayor Trotta read and presented the proclamation to her.

ON MOTION OF DEPUTY MAYOR SORCHIK, SECONDED BY COMMITTEEMAN MARINARI, THE PROCLAMATION PROCLAIMING MAY 2017 AS "PAINT THE TOWN PINK" MONTH WAS ADOPTED. ROLL CALL VOTE: ALL AYES

Kylie said Paint the Town Pink was in its eleventh year and are in 75 towns statewide. She said businesses are encouraged to register online to receive a free pink kit. Residents can go online to see events happening in the area. Mayor Trotta noted that the Township hangs a banner over Main Street and puts up pink bows. The Committee thanked her for coming.

Mayor Trotta asked Ann Funck, Coordinator of the Plumsted Municipal Alcohol and Drug Alliance to come forward to accept the proclamation for "National Alcohol Awareness Month" Connecting the Dots: Opportunities for Recovery" April 2017. Mayor Trotta read and presented the proclamation to Ms. Funck.

ON MOTION OF DEPUTY MAYKOR SORCHIK, SECONDED BY COMMITTEEMAN MARINARI, THE PROCLAMATION PROCLAIMING APRIL 2017 AS NATIONAL ALCOHOL AWARENESS MONTH, "CONNECTING THE DOTS: OPPORTUNITES FOR RECOVERY" WAS ADOPTED. ROLL CALL VOTE: ALL AYES

Ms. Funck thanked the Committee and wanted to thank them for recognizing Alcohol Awareness Month. She said a lot of work needs to be done and the Alliance is focusing on the youth in the Township. They have had a very busy year with programs in the schools, peer leaders, family dinner, and camp fire programs. They want to continue to bring awareness to addiction and alcoholism. She said there was always hope; alcohol is an addiction and a disease and can be cured. There is recovery and the resources are out there. She thanked the Committee and they thanked her for all she and the Alliance have done and are doing.

Deputy Mayor Sorchik said people now were talking about the opioid issue, but the surveys done in our community found that the drug most misused by the youth is alcohol, which is the most common drug. He wanted to remind parents and citizens that our town has an ordinance, and there is a State law. Now that prom season and graduation is coming up, it is against the law to host parties and serve alcohol to minors; it is a criminal offense. There is outreach in the various establishments that sell alcoholic beverages and they all agree that they try to keep it down and there are initiatives against this sponsored by Ann to make sure that that doesn't happen. He said his experience in law enforcement as a State Trooper where he saw this with first hand results. Over his 27 years where alcohol destroyed families because of intoxicated driving and such. He expressed and thanked Ms. Funck for all her efforts and everything the Municipal Alliance does in this municipality. It was noted that since prom season is approaching, the lawn signs for "Parents Who Host, Lose The Most" will be going up soon. She said there was a pre-prom meeting with parents to give them specifically what the laws are and how they can protect their children, what is acceptable and what is not acceptable. Ms. Funck thanked the Committee for all their support.

## **ORDINANCE INTRODUCTION:**

Mayor Trotta introduced Ordinance No. 2017-06 which adopts a Sanitary Sewer Connection Financial Incentive Program. He noted that on Page 14 of the Rules and Regulations, Section 3, Item 9D which currently states, "the amount of the loan will be reduced by 1/30 for each year the property is not sold or refinanced or where there has been a receipt of an insurance settlement which is not fully reinvested into the property as provided for herein." He said the Committee would like to have that line removed and just make it so that the loan would be forgiven after a total of 30 years. If they have any of those things go on anywhere during that 30-year period, the loan is payable in full, including the insurance.

The second reading and public hearing is scheduled for the next regularly scheduled meeting of May 3<sup>rd</sup>.

Mayor Trotta said the next item on the agenda was the budget presentation. He stated that the 2017 Budget was introduced at the March 1<sup>st</sup> meeting and the public hearing is scheduled at tonight's meeting. He noted the budget information is on the Plumsted Township Website (www.plumsted.org) and copies are available at the municipal building. He then presented an overview of the budget. The 2017 budget is just over \$3,500,000 which is \$95,580 more than last year. Salaries are \$1,439,289 which is \$49,405 more than last year. Total Operating Expenses are \$1,446,024, which is \$29,087 more than last year. The Township is within the 2% Tax Cap Law and the maximum tax is \$2,000,598 which is a \$33,845 tax increase or 1/2 cent increase on the tax rate. Total Municipal Tax Rate portion is .256 this year. He showed a comparison with other municipalities in Ocean County with respect to the municipal portion. He said regarding Plumsted's total tax bill, the schools are the highest portion of any towns' taxes at 62.1% of the tax bill, the County is 17.4%, Township is 9.7%, Fire District is 10% and Open Space is .8%. The total estimated in taxes from 2016 to 2017 increased \$307,527 or 1.53%.

Mayor Trotta asked if anyone from the public had any questions or comments on the budget. Since there were no comments, he closed the public hearing.

ON MOTION OF DEPUTY MAYOR SORCHIK, SECONDED BY COMMITTEEMAN MARINARI, THE PUBLIC HEARING ON THE 2017 BUDGET WAS CLOSED. ROLL CALL VOTE: ALL AYES.

Mayor Trotta said the next item was Resolution No. 2017-148 which authorizes the Township of Plumsted to conduct an annual Budget Self-Examination for the Year 2017. This is something that is normally done but the State wouldn't allow anyone in Ocean County to do it for the last few years because of Super Storm Sandy.

Mayor Trotta asked for any old or new business from the Committee.

Mayor Trotta said there were corrections to the November 14, 2016 Budget Workshop meeting. In the minutes where it states in part, "Board of Education will make money by the end of the year on the SROs but next year it will be lowered and the amount lowered \$38,400 because of pending legislation for Special 3's in the schools rather than SROs. There was a discussion regarding State Aid for school funding." The comments were made by June Madden, CFO, but the comments are being changed to "Regarding the Board of Education, we will make our monies before the end of the year on SROs but for next year you will see I have lowered the amount to \$38,400. As of right now I do not have any work on any grants so all of the grants that were received for 2016 are listed there."

Mayor Trotta said what she meant was still not clear because we were at the meeting and the Committee knew what she meant, but people reading the minutes do not understand. The agreement we have with school is revenue neutral for the SROs. So when it says make money, it does not mean either side going to profit from this, what she meant was the money that we were owed or the school was owed would be paid before the end of the year so that we were revenue neutral, but that was not how it was perceived when someone read it, so a correction was being made in public on that.

ON MOTION OF COMMITTEEMAN MARINARI, SECONDED BY DEPUTY MAYOR SORCHIK, THE CORRECTION ON THE MINUTES OF NOVEMBER 14, 2016 BUDGET WORKSHOP MEETING WAS AMENDED. ROLL CALL VOTE: ALL AYES.

Mayor Trotta asked for public comment.

Pat Ahearn of 8 Lawrence Drive had a question regarding the mandatory sewer hookup and asked when will the homeowners find out what that charge would be. Mayor Trotta said there were estimates at this time. This will be known after the PMUA adopts their Rules and Regulations. He said it depends on how far the house is from the road and the estimate is anywhere between \$4,000 and \$6,000. He suggested reaching out to Peter Ylvisaker, Executive Director of the MUA, who will advise you if sewers were going down Alton Road. It was explained that the ordinances introduced at this meeting regarding the financial incentive program and the mandatory hookup requirement will have a second reading and public hearing at the May 3<sup>rd</sup> Township Committee Meeting before they are adopted.

Mayor Trotta returned to Executive Session to finish a couple of items. There may be official action.
